## **Pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed) Patient Group Direction (PGD)**

This PGD is for the administration of pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed) (PCV13) to individuals from 12 weeks to under 2 years of age in accordance with the national immunisation programme for active immunisation against pneumococcal disease and to individuals from 6 weeks of age recommended PCV13 in response to an outbreak of pneumococcal disease.

This PGD is for the administration of PCV13 by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).





<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Indicated for the active immunisation of individuals from 12 weeks to under 2 years of age for the prevention of pneumococcal disease in accordance with the national immunisation programme and recommendations given in <a href="#">Chapter 25</a> of Immunisation Against Infectious Disease: the 'Green Book' and to individuals from 6 weeks of age recommended PCV13 in accordance with <a href="#">PHE Guidelines for the public health management of clusters and outbreaks of pneumococcal disease in closed settings with high-risk individuals</a>.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals from 12 weeks to under 2 years of age who:</p> <ul style="list-style-type: none"> <li>• require a primary dose of PCV13</li> <li>• require a reinforcing booster dose of PCV13 against pneumococcal disease</li> </ul> <p>Individuals from 6 weeks of age recommended PCV13 in accordance with <a href="#">PHE Guidelines for the public health management of clusters and outbreaks of pneumococcal disease in closed settings with high-risk individuals</a>.</p> <p>Note: Individuals with an underlying medical condition which puts them at increased risk from pneumococcal disease may require additional vaccination outside the inclusion criteria for this PGD - see PCV Risk Groups PGD and <a href="#">Chapter 25</a> of the 'Green Book'.</p>
<p><b>Criteria for exclusion<sup>2</sup></b></p>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are less than 12 weeks of age, unless PCV13 is recommended in response to an outbreak of pneumococcal disease</li> <li>• are aged 2 years and over, unless PCV13 is recommended in response to an outbreak of pneumococcal disease</li> <li>• have had a confirmed anaphylactic reaction to a previous dose of pneumococcal vaccine or to any component of the vaccine, including diphtheria toxoid</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p>	<p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects and additional doses may be recommended, see the 'Green Book' <a href="#">Chapter 7</a> and <a href="#">Chapter 25</a> and the PCV Risk Groups PGD.</p> <p>Premature infants should be vaccinated in accordance with the national routine immunisation schedule according to their chronological age. Very premature infants (born <math>\leq 28</math> weeks of gestation) who are in hospital should have respiratory monitoring for 48-72 hrs when given their first immunisation, particularly those with a previous history of respiratory immaturity. If the child has apnoea, bradycardia or desaturations after the first immunisation, the second immunisation should also be given in hospital, with respiratory monitoring for 48-72 hrs.</p>

<p><b>Action to be taken if the patient is excluded</b></p>	<p>If aged less than 12 weeks and born on or after 1/1/2020 advise to return for routine immunisation at 12 weeks of age and provide an appointment as appropriate. The PCV PGD V02.00 may continue to be used until 27/3/2020 to administer the first priming dose to individuals born on or before 31 December 2019 and less than 12 weeks of age. Immunisation can be administered to infants from 6 weeks of age if at increased risk of exposure due to an outbreak (see <a href="#">Dose and frequency of administration</a>).</p> <p>If aged 2 years and over routine immunisation with pneumococcal vaccine is not indicated. If the individual is at increased risk of pneumococcal disease, in accordance with the 'Green Book' <a href="#">Chapter 7</a> and <a href="#">Chapter 25</a>, refer to the PCV Risk Groups PGD.</p> <p>Individuals suffering acute severe febrile illness should postpone immunisation until they have recovered. Immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carer about the protective effects of the vaccine, the risks of infection and potential complications.</p> <p>Document advice given and the decision reached.</p> <p>Inform or refer to the GP as appropriate.</p>

## 5. Description of treatment

<b>Name, strength &amp; formulation of drug</b>	Pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed), PCV13: <ul style="list-style-type: none"> <li>• Prevenar® 13 suspension for injection in a pre-filled syringe</li> </ul>
<b>Legal category</b>	Prescription only medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>Administration of a two-dose primary series of Prevenar® 13 to pre-term infants &lt;37 weeks gestation born on or before 31 December 2019 is contrary to the 3-dose primary schedule detailed in the SPC but is in accordance with PHE recommendations for the <a href="#">vaccination of premature infants</a> and <a href="#">Chapter 25</a> of the 'Green Book'.</p> <p>Administration of a 1-dose primary series of Prevenar® 13 to individuals born on or after 1 January 2020 is contrary to the 2- or 3-dose primary schedule detailed in the SPC but is in accordance with PHE recommendations and <a href="#">Chapter 25</a> of the 'Green Book'.</p> <p>A single dose schedule for previously unvaccinated individuals between 12 months and up to 2 years of age is contrary to the 2-dose schedule detailed in the SPC but is in accordance with PHE recommendations for the <a href="#">vaccination of individuals with uncertain or incomplete immunisation status</a> and <a href="#">Chapter 25</a> of the 'Green Book'.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<b>Route / method of administration</b>	<p>Administer by intramuscular injection, preferably into the anterolateral aspect of the thigh in infants under one year of age. The deltoid region of the upper arm may be used in individuals over one year of age.</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an intramuscular route should be administered in accordance with the recommendations in the 'Green Book' <a href="#">Chapter 4</a> or the products <a href="#">SPC</a> to reduce the risk of bleeding.</p> <p>The vaccine's normal appearance is a uniform white suspension which may sediment during storage. Shake the prefilled syringe well to uniformly distribute the suspension before administering the vaccine.</p> <p>The vaccine should be visually inspected prior to administration and should not be used if discoloured or foreign particles are present.</p>

<p><b>Route / method of administration</b> continued</p>	<p>The vaccine's SPC provides further guidance on administration and is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Dose and frequency of administration</b></p> <p>Continued over page</p>	<p>Single 0.5ml dose per administration</p> <p><b>Routine Childhood Immunisation Schedule</b></p> <p><b><u>Infants born on or after 1 January 2020</u></b>, and who do not have asplenia, splenic dysfunction, complement disorder or severe immunocompromise<sup>3</sup>, should be offered a 1+1 PCV schedule, that is:</p> <ul style="list-style-type: none"> <li>• a single priming dose of PCV13 to be administered from 12 weeks of age, followed by</li> <li>• a PCV13 booster dose to be administered at one year old, on or soon after their first birthday and before 2 years of age.</li> </ul> <p>Since the immunogenicity of PCV13 will be lower if given at a younger age, any dose given before 12 weeks of age should not be counted as the single priming dose for the 1+1 schedule and the routine PCV dose should be given once the infant reaches 12 weeks of age, leaving a minimum 4-week interval between the priming dose and any preceding dose.</p> <p><b><u>Infants born on or before 31 December 2019</u></b>, should continue to be offered a 2+1 PCV schedule, that is:</p> <ul style="list-style-type: none"> <li>• a 2-dose priming schedule of PCV13 vaccine with an 8-week interval (routinely scheduled at 8 and 16 weeks of age) and</li> <li>• a booster dose to be administered at one year old, preferably on or soon after their first birthday and before 2 years of age.</li> </ul> <p>Note: Individuals with asplenia, splenic dysfunction, complement disorder and severe immunocompromise<sup>3</sup> also continue to require a 2-dose priming schedule of PCV13, a booster at one year old and an additional booster of PCV after the booster dose administered at one year old. Individuals with asplenia, splenic dysfunction, complement disorder and severe immunocompromise<sup>3</sup> should be vaccinated in accordance with the PCV Risk Groups PGD and <a href="#">Chapter 7</a> and <a href="#">Chapter 25</a> of the 'Green Book' and the first dose given as soon as possible ideally with the first primary immunisations if diagnosis is known.</p> <p><b>Unimmunised or partially immunised children</b></p> <p>Unimmunised or partially immunised infants <u>born on or after 1 January 2020</u> and who do not have asplenia, splenic dysfunction, complement disorder or severe immunocompromise<sup>3</sup> who present late for vaccination, and before one year of age, should receive a primary dose of PCV13 before the age of one year, and a booster dose at one year of age, leaving an 8-week interval between the primary PCV13 dose and the booster*.</p> <p>Unimmunised or partially immunised infants <u>born on or before 31 December 2019</u> who present late for vaccination should receive two doses of PCV13 8 weeks apart* before the age of one year (if possible), and a further dose at one year of age (8 weeks after the last PCV13 dose)*.</p> <p>*The immunisation interval may be reduced to 4-weeks if necessary to ensure the immunisation schedule is completed.</p>

<sup>3</sup> Examples of severe immunocompromise include bone marrow transplant patients, patients with acute and chronic leukaemia, multiple myeloma or genetic disorders affecting the immune system (such as IRAK-4, NEMO)

<p><b>Dose and frequency of administration</b> continued</p>	<p>An unimmunised or partially immunised child aged between one year and under two years of age should have a single dose of PCV13.</p> <p>See flow chart for <a href="#">vaccination of individual with uncertain or incomplete immunisation status</a>.</p> <p><b>Management of a pneumococcal disease clusters and outbreaks in closed settings with high-risk individuals.</b></p> <p>A single dose may be administered to adults and children from 6 weeks of age who have not received PCV13 vaccine in the preceding 4 weeks and who are identified as requiring PCV13 immunisation in accordance with <a href="#">PHE Guidelines for the public health management of clusters and outbreaks of pneumococcal disease in closed settings with high-risk individuals</a>. Note: PPV23 would ordinarily be used in an outbreak with the exception of serotype 6A/6C disease, individuals under 2 years of age, and where PPV23 is unavailable or otherwise inappropriate.</p>
<p><b>Duration of treatment</b></p>	<p>See <a href="#">Dose and frequency of administration</a> section above</p>
<p><b>Quantity to be supplied / administered</b></p>	<p>Single 0.5ml dose per administration.</p>
<p><b>Supplies</b></p>	<p>Centrally purchased vaccines for the national immunisation programme for the NHS can only be ordered via ImmForm. Vaccines for use for the national immunisation programme are provided free of charge.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see the 'Green Book' <a href="#">Chapter 3</a>).</p>
<p><b>Storage</b></p>	<p>Store at between +2°C to +8°C. Store in original packaging in order to protect from light. Do not freeze.</p> <p>Prevenar® 13 is stable at temperatures up to 25°C for four days. At the end of this period Prevenar® 13 should be used or discarded. These data are intended to guide health care professionals in case of temporary temperature excursions.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p>
<p><b>Disposal</b></p>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01: Safe management of healthcare waste</a> (Department of Health, 2013).</p>
<p><b>Drug interactions</b></p>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p>

<b>Drug interactions</b> continued	A detailed list of drug interactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a>
<b>Identification &amp; management of adverse reactions</b>	<p>Local reactions following vaccination are very common such as pain, swelling or redness at the injection site. A small painless nodule may form at the injection site.</p> <p>The most commonly reported adverse reactions include vaccination-site reactions, fever, irritability, decreased appetite, increased and/or decreased sleep, rash, vomiting and diarrhoea.</p> <p>Hypersensitivity reactions, such as bronchospasm, angioedema, urticaria, and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>

<b>Patient advice / follow up treatment</b>	<p>Inform the individual/parent/carer of possible side effects and their management.</p> <p>The individual/parent/carer should be advised to seek medical advice in the event of an adverse reaction.</p> <p>Advise the individual/parent/carer when any subsequent immunisations are due.</p> <p>When administration is postponed advise the individual/parent/carer when to return for vaccination.</p>
<b>Special considerations / additional information</b>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone at the time of vaccination.</p> <p>Individuals with asplenia, splenic dysfunction, complement disorder and severe immunosuppression<sup>3</sup> are at increased risk of pneumococcal disease and require additional doses of PCV13 in accordance with the 'Green Book' <a href="#">Chapter 7</a> and <a href="#">Chapter 25</a>.
